### Notification for Recruitment of Aircraft Technicians on Fixed Term Contract Basis

Al Engineering Services Limited (AIESL) is an Aircraft Maintenance, Repair and Overhaul (MRO) Organization, approved by DGCA (India) under CAR 145, and other international regulatory authorities to undertake MRO activities in India.

AIESL invites applications from Indian Nationals fulfilling the eligibility criteria and experience requirements as on 01<sup>st</sup> August 2023 for the post of AircraftTechnicians (B1, B2)/Technician (Welder/Fitter) from the open market on Fixed Term Employment basis.

The selected candidates will be posted at AIESL-MRO, Nagpur. Selected / Appointed Candidate may be transferred/ positioned to any other location /stations as per company requirement, during the course of employment. The Certificate should also contain the "Non-Creamy Layer" Clause.
